

Apollo Diversified Credit Fund

**Statement Pursuant to Section 19(a)
of the Investment Company Act of 1940**

On September 30, 2022, Apollo Diversified Credit Fund (the "Fund")¹ paid a distribution on its common stock to shareholders in the per share amounts listed below. Under U.S. Generally Accepted Accounting Principles (GAAP), the following table provides an estimate of the source of the September 30, 2022 distribution made by the Fund.

It is important to note that differences exist between the Fund's daily internal accounting records, the Fund's financial statements prepared in accordance with GAAP, and recordkeeping practices required under income tax regulations. Therefore, the characterization of Fund distributions for federal income tax purposes may be different from GAAP characterization presented above. The determination of what portion of each year's distributions constitutes ordinary income, qualifying dividend income, short or long-term capital gains or return of capital is reported to shareholders on Form 1099-DIV, which is mailed every year in late January. Though not guaranteed, the Fund's distribution policy is to make quarterly distributions to shareholders.
